CIRCULAR

Re: Amendments in Recruitment Rules for Class I and Class III

The board of the Corporation in its meeting held on 29th June, 2016 has approved the following amendments in the Recruitment Rules for Class I & Class III i.e amendments in "Recruitment Rules for Class I Officers, 2012" and "Recruitment Procedure for Supervisory, Clerical and Sub-ordinate staff".

There is a revision in the educational qualifications for General Recruitment, as mentioned in the table below:

EXISTING QUALIFICATIONS	REVISED QUALIFICATIONS
(A) OFFICERS	
For a Generalist Stream a candidate must possess the minimum qualification of a Graduate/ Post Graduate in any discipline from a recognized University.	For a Generalist Stream a candidate must possess the minimum qualification of a Graduate/ Post Graduate in any discipline from a recognized University with atleast 60% marks in either of the degree examination for General candidates and atleast 55% marks for SC/ST candidates.
For Specialist Stream (such as Legal, Accounts, Investment, Actuary, Management, Information Technology, Engineering, Veterinary Science, Medical, Company Secretary, etc.) a candidate must possess the minimum qualification of Degree in the relevant discipline from a recognized University.	For Specialist Stream (such as Legal, Accounts, Investment, Actuary, Management, Information Technology, Engineering, Veterinary Science, Medical, Company Secretary, etc.) a candidate must possess the minimum qualification of Degree in the relevant discipline from a recognized University with atleast 60% marks either of the degree examination for General candidates and atleast 55% marks for SC/ST candidates.



(B) CLASS III (ASSISTANT)	
(1) Graduate of recognized University or pass in HSC with 60% marks (50% for Ex-servicemen, SC/ST and Physically Handicapped candidates;	(1) Graduate of recognized University for all candidates.
(2) Knowledge of Regional knowledge i.e. language of the State of Recruitment is essential.	No change

All other terms and conditions in this regard remain unchanged.

The above provision will be effective from 1st July, 2016.
