Any format other than the mentioned format of the certificates will not be acceptable.

Please note that while submitting **Life Certificate for the Year 2022** your **E-mail IDs, Mobile No. and PAN** may please be mentioned clearly in the said certificate. A copy of PAN Card and Aadhar Card may be submitted along with the Certificate. This is **mandatory** for all pensioners.

For TAC Retirees, recent photograph is mandatorily required along with the abovementioned documents.

In case of change of Pension Bank Account Number and IFSC codes due to merger of various Nationalized Bank etc., a Xerox Copy of First page of Passbook and Cancelled cheque must be submitted along with Life Certificate.

Considering COVID 2019 Pandemic, pensioners and family pensioners are advised to send their duly filled in and certified copy of Life Certificate through email in PDF format along with requisite supporting documents, if any.
