I had joined the department on 20th January 1992 and retired on 30th June 2015 in which at the beginning Rs100 were deducted and later it had become Rs1000. The said amount is our right and now it has been more than 3 years that we have not received the Insurance Amount.</p> <p>A compulsory insurance policy was continued during the service period and we had deposited each instalment on regular basis before the retirement from the time of joining. We retired in 2015 the insurance matured with the end of our service period, but till now we have not received the insurance money from the Government Insurance Policy.</p> <p>I also want to mention that none of the teachers who had retired in 2015 had received Insurance Amount.
